INSTRUCTION TO BIDDERS FOR THE DISPOSAL OF UNSERVICEABLE PROPERTIES OF DSWD FO1

A. INSPECTION OD UNSERVICEABLE PROPERTIES

The unserviceable properties of DSWD FO1 is available for inspection/viewing on 18-30 November 2020 from Monday to Friday, 8:00 AM to 5:00 PM.

B. QUALIFICATION OF BIDDERS

All bidders who can comply with the documentary requirements of DSWD FO1 are qualified to participate in the Negotiated Sale.

C. SEALING AND MARKING OF BIDS

Proposals must be placed in a sealed envelope with the following details:



All bids submitted should be properly accomplished and sealed, any bid falling under the following condition/situation shall be considered invalid:

- 1. Bid is unsealed;
- 2. Bid is unsigned by the bidder; and
- 3. Insufficient/No Bid Bond

D. SCHEDULE OF OPENING OF SEALED BIDS

The negotiated sale shall be conducted on "as is, where is" basis by the Regional Property and Awards Committee (RPDAC).

Bid proposals shall be submitted to the RPDAC Secretariat not later than 12:00 noon of 1 December 2020. Opening and deliberation of sealed bids will be at 1:00 PM at the same date, to be held at Model Senior Citizen Center, Quezon Avenue, City of San Fernando, La Union (at the back of DSWD FO1 Building).

Bids submitted beyond the deadline shall no longer be accepted.



E. MODIFICATION AND WITHDRAWAL OF BID

- A bidder may modify its bid after it has been submitted provided that the submission of modified bid is received by the RPDAC Secretariat before the deadline of submission of bids; and
- 2. A bidder may be allowed to withdraw his/her bid prior to opening of bids and shall be returned to him/her unopened. A bidder may, through a Letter of Withdrawal, withdraw its bid after it has been submitted for valid and justifiable reason and must be received prior to the deadline of submission of bids.

F. SUBMISSION OF BIDS AND BOND

Prospective bidders must submit the following documents during the scheduled opening of sealed bids:

- Copy of the bidders or his/her representative Identification Card (ID) issued by the government;
- 2. Copy of the latest Business/Mayor's Permit;
- Copy of Permit to operate/Environmental Compliance Certificate/Certificate of Noncoverage issued by DENR
- 4. Bid Form
- 5. Duly signed Instruction to Bidders
- 6. Bidder's Bond in the form of cash in the amount equivalent to at least ten percent (10%) of the Total Bid Offer

G. OPENING OF BIDS

- The RPDAC, constituted by a quorum and presided by the Chairperson or the Vice Chairperson shall open all bids received within the deadline, at the date, time, and place set in the invitation;
- Representatives from the Commission on Audit (COA) shall be invited to witness the opening of bids;
- 3 An Abstract if Bids "as Read" shall be prepared by the RPDAC Secretariat for signature of the RPDAC members and shall be approved by the Regional Director or his authorized representative; and
- 4. After all bids have been opened and tabulations completed, the Presiding Officer shall announce the name of the highest complying bidder and the amount of his/her bid.
- 5. The Bid Bond of the losing/disqualified bidder shall be returned to them after the announcement of results.

H. AWARDING OF BIDS

- 1. Award shall be made to the highest bidder;
- The Notice of Award shall be issued by the RPDAC to the winning bidder within three (3) working days from the opening of bids;
- 3. The bidder whose offer is considered the most advantageous to the government shall be awarded, provided the offer shall not be less than the minimum bid set by the RPDAC. In case of tie, the bidders involved shall immediately submit another sealed bid which shall, likewise, be open until such tie is broken; and



4. If the winning bidder refuses to accept the award, the next highest bidder shall be awarded the bid, so forth and so on. However, any bidder who refuses to accept the award SHALL BE EQUIRED TO PAY THE DIFFERENCE BETWEEN SAID BIDDER AND THAT OF THE NEXT BIDDER, shall be blacklisted and shall not be allowed to participate in the future biddings, without prejudice to RPDAC's other courses of action and remedies open to it.

I. PAYMENT

- 1. One-time payment in CASH shall be made within three (3) calendar days from the date of receipt of Notice of Award;
- 2. The Bid Bond of the winning bidder shall be considered as partial payment of the Final Bid Price. The difference between the Final Bid Price and Bid Bond shall be paid in the form of cash to the DSWD FO1 Cashier (Ang Bid Bond ng magwawaging bidder ay magiging paunang bayad niya. Ang natitirang halaga ay dapat bayaran sa loob ng tatlong araw sa Cashier lamang ng DSWD FO1);
- 3. An Official Receipt (OR) shall be issued by DSWD FO1 covering the payment made by the winning bidder;
- 4. In addition to the amount of sale, the winning bidder shall also pay taxes, cost or charges of any kind in connection with the sale of the materials; and
- 5. In case the winning bidder fails to make the payment within the prescribed period, said bidder will be blacklisted and shall not be allowed to participate in the future biddings.

J. PICK-UP/HAULING OF PROPERTY BY THE WINNING BIDDER

- 1. The winning bidder shall be given five (5) calendar days from receipt of Notice to Proceed;
- 2. The winning bidder shall pick-up/haul the unserviceable properties from the following locations:
 - a. PSMS Warehouse, Urayong, Bauang, La Union
 - b. Regional Rehabilitation Center for Youth (RRCY), Urayong, Bauang, La Union
 - c. Home for Girls (HFG), San Nicolas West, Agoo, La Union
 - d. Bonuan Binloc, Dagupan City:
 - Area 1 Vocational Rehabilitation Center (AVRC1)
 - Haven for Children (HFC)
 - Haven for Women (HFW)
- 3. The winning bidder can only claim the articles after he/she has fully paid the total amount of sale as evidenced by an Official Receipt. He/she shall only able to withdraw the sold items upon presentation of a duly accomplished Tally Out Sheet/Gate Pass together with a copy of the OR, in coordination with the RPDAC and shall be made only during working hours and within the fixed period fixed by the RPDAC.
- Expenses incidental to the pick-up/hauling of property shall be borne by the winning bidder (Anumang bayarin at gastusin kaugnay sa pagbebenta at paglilipat ng mga articles ay babalikatin ng magwawaging bidder.); and
- 5. In case the winning bidders fails to complete the pick-up/hauling of property within the prescribed period, the award shall be cancelled/revoked. The next highest bidder shall be awarded the bid, so forth and so on.



K. FORFEITURE /RETURN OF BID BOND

- 1. The bid bond shall be forfeited in favor of DSWD FO1 in the following instances:
 - a. The winning bidder refuses to accept the award;
 - b. In case the winning bidder fails to make the payment within the prescribed period; and
 - c. The winning bidder fails to complete the pick-up/hauling of the property within the prescribed period.

L. FAILURE OF BIDDING

Failure of bidding shall be declared in the following instances:

- a. If prospective bidders are declared ineligible;
- b. No bids are received;
- c. All bids fail to comply with the requirement;
- d. All bid below the minimum bid price; and
- e. The winning bidder refuses to accept the award or fails to make payment as required;
