DSWD FIELD OFFICE 1 GENDER AND DEVELOPMENT NARRATIVE REPORT OF ACCOMPLISHMENTS FOR CY 2021

I. INTRODUCTION

Despite the threat and struggle of the country brought by the COVID-19 pandemic, the DSWD Field Office 1 through its active Regional Gender and Development Technical Working Group continues to implement gender and development programs, projects, and activities (GAD PPAs) as committed in the Gender and Development Plan and Budget. The DSWD staff tagged as the Angels in Red Vest are ready to serve the poor, vulnerable, marginalized and disadvantaged sectors of the community to eliminate any form of discrimination and ensure social equity and justice across sectors.

The client-focused PPAs, organization focused PPAs, and attributed programs of the Department were efficiently implemented as its responds to gender issues and adheres to GAD mandates. The attributed programs have undergone harmonized gender and development guidelines (HGDG) assessment to measure the gender-responsiveness of its services to clients.

II. STATISTICAL ACCOMPLISHMENTS

CLIENT-FOCUSED PPAS

Provision of assistive devices

For the year, the Older Persons/Persons with Disability Focal Person was able to serve 70 (23 females and 47 males) PWDs from the different Municipalities of the Region, they were provided financial assistance for the purchase of assistive devices (wheelchair). Every end of the year, the MOVE DSWD FO 1 Chapter General Assembly cum Team Building is conducted at R-Buffet, City of San Fernando, La Union. For CY 2021, the assembly was attended by 50 males on 21 December 2021. As a result of orientation at the local level, MOVE was able to organize nine men's group in the three Barangays of Aringay, La Union, one in the Municipalities of Agoo, Bagulin, Sudipen, Tubao, Bauang, and Burgos in the Province of La Union.

Regulatory Services

The Standards Section ensures the quality of service delivery of the SWDAs and service providers. Haven for Women and Home for Girls was pre-assessed and the Standards Bureau accredited these Centers and was confirmed as Level III for the year.

Disaster Response and Management Program

For the provision of immediate relief and early recovery of disaster victims/survivors, there are 184,177 families provided with relief assistance; 15,721 hygiene kits were distributed, 5,474 for the COVID-19 affected individuals, 173 for victims of fire incidents, and 10,074 for individuals affected by Typhoon Maring. There is also an established evacuation Center with Child Friendly Spaces and Women Friendly Spaces in the Region located at Sta. Barbara, Pangasinan. There are 6,794 beneficiaries provided with Emergency Shelter Assistance, 50,997 beneficiaries provided with Cash for Work, and there are 3,392 families with casualties provided with outright assistance.

Protective Services for Individuals, Families and Communities in Need or in Crisis

The Crisis Intervention Section provided medical assistance to 142 males and 37 females with HIV/AIDS; educational assistance to 4,983 males and 10,169 females; medical assistance to 9,724 males and 21,552 females; financial assistance to 612 males and 104 females Distressed Overseas Filipinos; psychological counseling and intervention to 9,724 males and 21,552 females. The Section also maintains Children and Women's Desk and maintains confidential files stored in a safe filing cabinet.

For the assistance to Former Rebels (FRs), the CIS served two FRS for the year, the Sustainable Livelihood Program served nine FRs provided with livelihood assistance, Pantawid Pamilyang Pilipino Program served 3 FRs.

Access to the DSWD Lactation Room

Access to the DSWD Lactation Room is available to its external clients. For the year, there is only one female client who used the lactation room.

International Social Services Office

For the services to Distressed Overseas Filipinos who are victim-survivors of trafficking, the International Social Services Office was able to serve 15 female victims of abuse, 4 male and 14 female victims of unfair labor practice, 105 males and 188

females repatriates, 4 males and 1 female accused/suspected with criminal charges, 94 males and 166 females with documentary related. There are 6 females and 5 males referred to the Sustainable Livelihood Program for livelihood assistance.

Social Technology

In terms of Social Technology (ST) marketing, there are 3 STs marketed to intermediaries, the Comprehensive Intervention Against Gender-Based Violence (CIAGV), Counseling for the Rehabilitation of Perpetrators of Domestic Violence (CSRPDV), and Enhanced National Family Violence Prevention Program (ENFVPP). These STs was marketed to 34 LGU (Ilocos Sur and Ilocos Norte) participants on 18 August 2021 and to 47 LGU (La Union and Pangasinan) participants on 27 October 2021 via zoom.

Social Marketing

The Social Marketing Section was able to produce 23 GAD-related IEC Materials, 44 press releases, and 11 information caravans.

Technical Mentoring to LCAT-VAWCs and Sustained Submission of Accomplishment Report of the Inter-Agency

The objective of the technical mentoring is to enable the LCAT-VAWC Representatives to be more adept with the provisions of the different laws of RA 9262, RA 9775, RA 9262 as well as RA 11313 as another GBV law of concern. An Orientation and Technical Mentoring to LCAT-VAWCs was conducted in two batches, the 1st Batch was attended by 16 participants (2 males and 14 females) conducted at Kahuna Beach Resort and Spa, San Juan, La Union on 25-26 November 2021 and the 2nd Batch attended by 17 participants (3 males and 14 females) conducted at Leisure Coast, Dagupan City, Pangasinan on 9-10 December 2021. As part of the inter-agency's commitment, one accomplishment report of the Inter-Agency Committee was regularly submitted to the Central Office.

Established Grievance System

The DSWD Field Office 1 was able to establish a grievance system handled by the Human Resource Welfare Section. For the year, there are no GAD-related grievances handled by the Section.

There are nine programs assessed as to gender responsiveness for the year.

Access of employees to flexible work arrangement

Distribution of Advocacy materials

The RIACAT-CP-VAWC Led Secretariat distributed 100 pieces advocacy shirts, 100 pouches, and 100 tumblers during the CY 2021 National Women's Month Celebration. The women focal person also distributed 100 posters, 200 advocacy shirts, 96 tumblers, and 100 puches during the 18-Day Campaign to End VAW. These advocacy materials was distributed to Field Office 1 staff and LGU partners. Face-to-face activities of the Inter-Agency were not yet conducted due to the threat of the COVID-19 pandemic.

Capability Building Trainings

For CY 2021, the Field Office was able to conduct the Regional Project Monitoring and Evaluation Technical Team (RPMETT) Specialized Training to 32 (6 males and 26 females) participants RPMETT members at Monarch Hotel, Calasiao, Pangasinan on 26-28 May 2021 and the IntegriTalk:Leadership and Management Training was also conducted attended by 40 (12 males and 28 females) participants at Kahuna Beach Resort and Spa, San Juan, La Union on 1-3 December 2021

Updating of GAD Corners

One of the RGAD-TWG commitments is to update GAD Corners as needed. For the Field Office, there are 10 GAD Corners established and updated regularly.

ICT Security

The RICTMS conducted daily monitoring of ICT security for the proliferation of pornographic sites.

Gender Sensitivity Trainings

The Field Office conducted two batches of Gender Sensitivity Training for the year. It was attended by 26 males and 28 females, Batch 1 was conducted on 16-19 March 2021 and Batch 2 was conducted on 2-5 November 2021 held at Em Royalle Hotel and Beach Resort, San Juan, La Union.

Sustained Gender Analysis Trainings

The RGAD-TWG's training on the use of Gender Analysis was sustained. There are 45 (9 males and 36 females) members trained on the use of Harmonized Gender and Development Guidelines (HGDG) conducted on 20-24 September 2021 at Kahuna Beach Resort and Spa, San Juan, La Union that was inserted as one of the activities during the GAD Planning and Budgeting Workshop. The objective of the training is to enhance the knowledge and skills of the RGAD-TWG in administering the HGDG tool. The Learning Service Provider presented the tool with the needed Means of Verifications that will serve as guide to the members.

Human Resource Welfare Services

The Human Resource Welfare Section provided psychosocial counseling and intervention to 155 males and 301 females of the Field Office. The Section was able to conduct Kamustahan for the employees who are COVID-19 recovered patients. They are also maintaining a Lactation Room for DSWD Employees and also caters external clients.

Access of employees to the DSWD Lactation Room

There are five female employees from the different Divisions (two from the Statutory Programs Division, one from the Policy and Plans Division, one from the Finance and

Management Division, and one from the Human Resource Management and Development Division) of the Field Office who used the Lactation Room for the year. The Lactation Room is equipped not only for mothers to breastfeed, but also to extract milk and preserve so they can bring home to their babies. The Office also allows mothers to take care of their young infants, an additional 40 minutes break during the day is allowed to those who resides near the office. Majority of the lactating mothers are on work from home arrangement.

Disaster Response and Management Program

In the last thirty years, the Philippines was battered by various natural and man-made disasters, like volcanic eruptions, typhoons, floods, fire, earthquakes, among others whose magnitude have affected countless lives. The frequency and intensity of hazards and disasters forced the government, civil society organizations, development partners and other groups to step up their disaster-related efforts. Recently, the Sendai Framework for Disaster Risk Reduction for 2015-2030 was introduced strongly emphasizing disaster risk management and aims to preventing new risk, reducing existing risk and strengthening resilience, and identifies seven global targets and establishes a set of guiding principles, including "primary responsibility of states to prevent and reduce disaster risk, all-of-society and all-of-State institutions engagement." As stated in the Section 10 of the Republic Act No. 9710, also known as the Magna Carta of Women, spells out the rights of women affected by disasters, calamities and other crisis situations. Specifically, women have the right to protection and security in all phases of relief, recovery, rehabilitation, and construction efforts. The State shall, "provide for immediate humanitarian assistance, allocation of resources, and early resettlement, if necessary;" and address the needs of women "from a gender perspective to ensure their full protection from sexual exploitation and other sexual and gender-based violence committed against them." Among the responses to disaster shall be the provision of services, such as psychosocial support, livelihood assistance, education, and comprehensive health services, including protection during pregnancy.

As the agency in charge in response services, various Capability Building Trainings was conducted to capacitate the Field Office staff in the discharge of their functions during disasters. For CY 2021, the DRMD was able to conduct four trainings to adhere on the above-stated law during disasters as indicated below:

GAD-ATTRIBUTED PROGRAMS OR PROJECTS

Centers and Institution

Home for Girls was able to serve 57 girl children and 2 male dependents, Haven for Women served 57 women and 27 (16 females and 11 males) dependents, the Regional Rehabilitation Center for Youth served 94 male CICLs, Haven for Children served 39 male children, while the Area 1 Vocational Rehabilitation Center served 153 (76 males and 77 females) PWDs. These clients were provided with temporary shelter, medical services, educational services, psychological/psychiatric services, practical skills development, livelihood assistance, social services, homelife services, recreational sports and other socio-cultural activities, spiritual services, among others.

Pantawid Pamilyang Pilipino Program

There are 202,916 Pantawid beneficiaries (200,569 - 34,003 males and 166,566 female RCCT beneficiaries and 2,348 - 673 males and 1,675 female MCCT beneficiaries) provided with PhilHealth services, and 4,568 IP beneficiaries provided with livelihood assistance. Due to the threat of the COVID-19 pandemic, the Youth Development Session and Family Development Session were not conducted face to face, the program distributed FDS Komiks to 34,285 male RCCT and MCCT beneficiaires and 162,036 female RCCT and MCCT beneficiaries as an alternative that is also used for the conduct of YDS and FDS. Face to face activities like Home visits and gender sensitivity trainings were temporarily suspended due to the pandemic. The Program was able to refer 296 (100 males and 196 females) parent grantees and 30 (5 males and 25 females) solo parents to the Sustainable Livelihood Program for assistance.

Recovery and Reintegration Program for Trafficked Persons

The Recovery and Reintegration Program for Trafficked Persons was able to serve 13 males and 58 females trafficking in persons (TIPs) for the year. They were provided with medical assistance, livelihood assistance, transportation assistance, temporary

shelter, legal services among others. Their families and dependents were also provided with livelihood assistance and educational assistance respectively.

Sustainable Livelihood Program

The Sustainable Livelihood Program provided trainings and Seed Capital Fund to 9,616 women beneficiaries. There were no organized SLPAs for the year due to implementation of the Livelihood Assistance Grants (LAG) distribution.
