 - d. There is no copy of:

 Valid Business/Mayor's Permit or electronic official receipt as proof of payment for the renewal and the latest Business/Mayor's Permit;
Valid Business/Mayor's Permit kasama ng electronic receipt o kopya ng latest Business/Mayor's Permit;



- Valid I.D and latest notarized SPA or Authority Letter for the bidder/s duly authorized representative attending the activity.
 Valid I.D at latest notarized SPA or Authority Letter ng kinatawan ng bidder na dadalo sa activity.
- e. Inclusion of Item 21: All prospective bidders are required to conduct <u>SITE VISIT / OCULAR INSPECTION</u>. A Certificate of Inspection shall be issued by the RPDAC Secretariat which shall form part of the "Documentary Components" Envelope 1 upon submission of the bid. Bidders who failed to conduct site visit / ocular inspection shall be disqualified.
