WHEREAS, the DSWD Field Office 1 – Policy and Plans Division – Regional Information and Communications Management Section through the Bids and Awards Committee (BAC) requested for the Internet Connection for DSWD Field Office 1 and Other Sub-Regional Sites in Region 1 for the Period May-December 2024 (Project Identification No. 24-DSWDFO1-01) with a total ABC of Ten Million Six Hundred Forty-nine Thousand Five Hundred Twenty-six Pesos (PhP10,649,526.00) only and categorized to the following lots:

1	Primary Internet Service for 16 DSWD FO 1 Sites in Region 1	PhP7,241,526.00
2	Secondary Internet Service for 16 DSWD FO 1 Sites in Region 1	PhP3,408,000.00

WHEREAS, the Competitive Bidding procedure for Goods was adopted in this undertaking pursuant to Republic Act No. (R.A.) 9184 otherwise known as the Government Procurement Act (GPRA) and its Implementing Rules and Regulations (IRR);

WHEREAS, the Invitation to Bid (IB) was posted at the Philippine Government Electronic Procurement System (PhilGEPS), at the DSWD FO 1 website, and at conspicuous places within the Department premises from 11- 29 January 2024;

WHEREAS, in response to the IB, one (1) bidder, namely PLDT, INC. (Lot No. 1 ^ 2) purchased the Bidding Documents and paid its non-refundable cost;

WHEREAS, during the deadline of submission and opening of bids scheduled on 29 January 2024 at 9:00 AM and 10:00 AM, respectively , PLDT, INC. (Lot No. 1 and 2) came to submit its bid proposal;

WHEREAS, during the preliminary examination of the documents submitted by the bidder, the BAC found that the bid of PLDT, INC. for Lot No. 1 & 2 was deemed **failed** due to the absence of Notice of Award, Notice to Proceed, Official Receipt/s and/or Disbursement Vouchers, and User's/Owner's Certificate of Completion to support its Single Largest Completed Contract (SLCC) for Lot No. 1 & 2. The Financial Component was not opened for Lot No. 1 & 2;

WHEREAS, under Section 35.1 of the IRR of RA 9184:

The BAC shall declare the bidding a failure when:

- c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; or

NOW THEREFORE, in view of the foregoing and on the basis of the documents and circumstances presented, the Bids and Awards Committee resolves as it is hereby resolved to recommend to declare a failure of bidding for the Internet Connection for DSWD Field Office 1 and Other Sub-Regional Sites in Region 1 for the Period May-December 2024 and re-advertise the opportunity upon review and revision of the technical specifications;
