#### RECOMMENDING AWARD OF CONTRACT FOR THE PROJECT: NEGOTIATED PROCUREMENT FOR THE INTERNET CONNECTION FOR DSWD FIELD OFFICE 1 AND OTHER SUB-REGIONAL SITES IN REGION 1 FOR THE PERIOD MAY-DECEMBER 2024

WHEREAS, the DSWD Field Office 1 – Policy and Plans Division – Regional Information and Communications Technology Section through the Bids and Awards Committee (BAC) requested for the Negotiated Procurement for the Internet Connection for DSWD Field Office 1 and Other Sub-Regional Sites in Region 1 for the Period May-December 2024 (Lot No. 2 & Lot No. 3) (Project Identification No. NNP No. 24-DSWDFO1-02) with a total Approved Budget for the Contract (ABC) amounting to Three Million Six Hundred Eighteen Thousand Pesos (PhP3,618,000.00) categorized to the following lots:

WHEREAS, the Competitive Bidding procedure for Goods was adopted in this undertaking pursuant to Republic Act No. (R.A.) 9184 otherwise known as the Government Procurement Act (GPRA) and its Implementing Rules and Regulations (IRR);

**WHEREAS**, the Notice of Negotiated Procurement: Two (2) Failed Biddings was posted at the Philippine Government Electronic Procurement System (PhilGEPS), DSWD FO 1 website and at conspicuous places within the Department premises from 05-15 March 2024;

WHEREAS, in response to the notice, three (3) bidders, namely, INNOVE COMUNICATIONS, INC. (Lot No. 2), CONVERGE INFORMATION AND COMMUNICATIONS TECHNOLOGY SOLUTIONS, INC. (Lot No. 2 & 3) and PLDT, INC. (Lot No. 3) came to submit their bid proposals;

WHEREAS, during the preliminary examination of the bid documents, the BAC decided on the following:

WHEREAS, the Technical Component of CONVERGE INFORMATION AND COMMUNICATIONS TECHNOLOGY SOLUTIONS, INC. (Lot No. 3) was declared failed due to incomplete financial component envelopes. The bidder has no financial component for the for the original and copy 2 envelopes. Its Financial Component was not opened;

WHEREAS, during the bid evaluation conducted on 18 March 2024 and postqualification on 21 & 25 March 2024, it was found out that CONVERGE INFORMATION AND COMMUNICATIONS TECHNOLOGY SOLUTIONS, INC. (LOT NO. 2) and PLDT, INC. (Lot No. 3) complied with all the requirements and passed the post-qualification;
