WHEREAS, the DSWD Field Office 1 – Administrative Division through the Bids and Awards Committee (BAC) requested for the Provision of Plated or Packed Meals and Snacks for DSWD Field Office 1 Activities for CY 2024 Through Framework Agreement (Re-Advertisement) (Project Identification No. 24-DSWDFO1-03A) at the Philippine Government Electronic Procurement System (PhilGEPS), with a total Approved Budget for the Contract (ABC) of One Million Pesos (PhP1,000,000.00) only;

WHEREAS, the Competitive Bidding procedure for Goods was adopted in this undertaking pursuant to Republic Act No. (R.A.) 9184 otherwise known as the Government Procurement Act (GPRA) and its Implementing Rules and Regulations (IRR);

WHEREAS, the Invitation to Bid (IB) was posted at the DSWD FO 1 website, and at conspicuous places within the Department premises from 05-24 April 2024;

WHEREAS, when the deadline for submission of bids lapsed on 24 April 2024 at 9:00 AM, no bid was received;

WHEREAS, under Section 35.1 of the IRR of RA 9184:

The BAC shall declare the bidding a failure when:
