WHEREAS, the DSWD Field Office 1 – Statutory Programs Division – Crisis Intervention Section through the Bids and Awards Committee (BAC) requested for the Purchase and Delivery of Furniture & Fixtures for Crisis Intervention Section of DSWD Field Office 1 Project Identification No. 24-DSWDFO1-04) at the Philippine Government Electronic Procurement System (PhilGEPS), with a total Approved Budget for the Contract (ABC) of One Million Five Hundred Thirty-nine Thousand Seven Hundred Ninety-three Pesos (PhP1,539,793.00) only;
