## RECOMMENDING AWARD OF CONTRACT FOR THE PROJECT: PURCHASE AND DELIVERY OF FURNITURE & FIXTURES FOR CRISIS INTERVENTION SECTION OF DSWD FIELD OFFICE 1 (RE-ADVERTISEMENT)

## PROJECT IDENTIFICATION NO. 24-DSWDFO1-04A | PR No. 2024-06-1150

WHEREAS, the DSWD Field Office 1 – Statutory Programs Division – Crisis Intervention Section through the Bids and Awards Committee (BAC) requested for the Purchase and Delivery of Furniture & Fixtures for Crisis Intervention Section of DSWD Field Office 1 (Re-Advertisement) (Project Identification No. 24-DSWDFO1-04A) with an Approved Budget for the Contract (ABC) amounting to One Million Five Hundred Thirty-five Thousand Eight Hundred Pesos (PhP1,535,800.00) only;

**WHEREAS**, the Competitive Bidding procedure for Goods was adopted in this undertaking pursuant to Republic Act No. (R.A.) 9184 otherwise known as the Government Procurement Act (GPRA) and its Implementing Rules and Regulations (IRR);

**WHEREAS**, the Invitation to Bid (IB) was posted at the Philippine Government Electronic Procurement System (PhilGEPS), DSWD FO 1 website and at conspicuous places within the Department premises from 20 June 2024 – 08 July 2024;

WHEREAS, the BAC issued Supplemental/Bid Bulletin No. 1 on 26 June 2024 rescheduling the pre-bid conference, submission of bids and bid opening as follows:

**WHEREAS,** during the deadline of submission and opening of bids scheduled on 12 July 2024 at 9:00 AM and 10:00 AM, respectively, Suntawood Home and Office, Inc. and Progress Home and Office Furnishings came to submit their bid proposal;
