DECLARING FAILURE OF BIDDING FOR THE PROJECT: PURCHASE, DELIVERY, AND INSTALLATION OF AIRCONDITIONING UNITS FOR CENTERS AND RESIDENTIAL CARE FACILITIES (CRCFs)

WHEREAS, the DSWD Field Office 1 – Center and Residential Care Facilities (CRCF) through the Bids and Awards Committee (BAC) requested for the Purchase, Delivery, and Installation of Airconditioning Units for Centers and Residential Care Facilities (CRCFs) (Project Identification No. 24-DSWDFO1-05) with a total ABC amounting to Three Million Six Thousand Seven Hundred Six Pesos & 11/100 (PhP3,006,706.11) broken down to the following lots:

WHEREAS, the Competitive Bidding procedure for Goods was adopted in this undertaking pursuant to Republic Act No. (R.A.) 9184 otherwise known as the Government Procurement Act (GPRA) and its Implementing Rules and Regulations (IRR);

WHEREAS, the Invitation to Bid (IB) was posted at the Philippine Government Electronic Procurement System (PhilGEPS), at the DSWD FO 1 website, and at conspicuous places within the Department premises from 04-24 July 2024;

WHEREAS, the BAC issued Supplemental/Bid Bulletin No. 1 on 15 July 2024 re: Rescheduling the Bid Submission and Bid Opening from 24 July 2024 to 31 July 2024

WHEREAS, in response to the IB, DEOKMA EIGHT TRADING INC. (Lot No. 1, 2, 3, 4, & 5) purchased the Bidding Documents and paid its non-refundable cost;

WHEREAS, during the deadline of submission and opening of bids scheduled on 31 July 2024 at 9:00 AM and 10:00 AM, respectively, DEOKMA EIGHT TRADING INC. (Lot No. 1, 2, 3, 4, & 5) came to submit its bid proposal;

WHEREAS, during the preliminary examination of the documents submitted by the bidder, the Bids and Awards Committee found that DEOKMA EIGHT TRADING INC. (Lot No. 1, 2, 3, 4, & 5) complied and are eligible;

WHEREAS, during the bid evaluation, the bid of DEOKMA EIGHT TRADING INC. (Lot No. 1, 2, 3, 4, & 5) was deemed failed by the BAC-TWG due to inconsistent figures on its financial component. Copies of the minutes of the meeting for bid evaluation and BAC Resolution No. 054A are attached marked as Annex "A" and "A-1" and made integral parts hereof;

WHEREAS, under Section 35.1 of the IRR of RA 9184:

The BAC shall declare the bidding a failure when:

- c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of Consulting Services, there is no successful negotiation; or

NOW THEREFORE, in view of the foregoing and on the basis of the documents and circumstances presented, the Bids and Awards Committee resolves as it is hereby resolved to recommend to declare a failure of bidding for the Purchase, Delivery, and Installation of Airconditioning Units for Centers and Residential Care Facilities (CRCFs).
