# RECOMMENDING AWARD OF CONTRACT FOR THE PROJECT: PROCUREMENT OF INFORMATION TECHNOLOGY EQUIPMENT FOR SUSTAINABLE LIVELIHOOD PROGRAM STAFF

WHEREAS, the DSWD Field Office 1 – Specialized Programs Division – Sustainable Livelihood Program through the Bids and Awards Committee (BAC) requested for the Procurement of Information Technology Equipment for Sustainable Livelihood Program Staff (Project Identification No. 24-DSWDFO1-07) with an Approved Budget for the Contract (ABC) amounting to One Million Six Hundred Seventy-nine Thousand Nine Hundred Eighty-two Pesos (PhP1,679,982.00) only;

WHEREAS, the Competitive Bidding procedure for Goods was adopted in this undertaking pursuant to Republic Act No. (R.A.) 9184 otherwise known as the Government Procurement Act (GPRA) and its Implementing Rules and Regulations (IRR);

WHEREAS, the Invitation to Bid (IB) was posted at the Philippine Government Electronic Procurement System (PhilGEPS), DSWD FO 1 website and at conspicuous places within the Department premises from 20 August 2024 – 09 September 2024;

**WHEREAS**, in response to the IB, one (1) bidder, Jonecotech Marketing Corp. purchased the Bidding Documents and paid its non-refundable cost;

**WHEREAS**, during the deadline of submission and opening of bids scheduled on 09 September 2024 at 9:00 AM and 10:00 AM, respectively, Jonecotech Marketing Corp. came to submit its bid proposal;

WHEREAS, during the preliminary examination of the bid documents, Jonecotech Marketing Corp. passed and complied with the technical specifications and therefore evaluated as responsive;

WHEREAS, the bid offer of Jonecotech Marketing Corp. for the project is One Million Four Hundred Thirty-four Thousand Ninety Pesos (PhP1,434,090.00) only. Copies of the Abstract of Bids – Technical Component and Abstract of Bids – Financial Component are hereto attached, marked as Annex "B", and Annex "B-1" and made integral parts hereof;

WHEREAS, during the bid evaluation conducted on 09 September 2024 and post-qualification on 17 September 2024, it was found out that Jonecotech Marketing Corp. complied with all the requirements and passed the post-qualification. Copies of the Bid Evaluation Report, Abstract of Bids "As Evaluated" and Post-Qualification Report are hereto attached, marked as Annex "D", and Annex "E" and made integral parts hereof;

**NOW THEREFORE**, in view of the foregoing and on the basis of the documents and circumstances presented, the Bids and Awards Committee resolves as it is hereby resolved to recommend the award of contract for the "Procurement of Information Technology Equipment for Sustainable Livelihood Program Staff" to Jonecotech Marketing Corp. for being the Single Calculated & Responsive Bidder (SCRB) with a contract amount of One Million Four Hundred Thirty-four Thousand Ninety Pesos (PhP1,434,090.00) only;
