- iii. Performance Security is hereto attached;
- Notice of Award of Contract; and the Bidder's conforme thereto attached;
 and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Two Million One Hundred Thirty-Seven Thousand Five Hundred Pesos (PhP2,137,500.00) Only, as contract price or such other sums as may be ascertained, Castech Ind'l Sales Inc. agrees to provide Purchase and Delivery of Plastic Pallets for DSWD Field Office 1 Regional and Satellite Warehouse in accordance with his/her/its Bid.



The DSWD FO 1 agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
