CONTRACT AGREEMENT

THIS AGREEMENT made and entered into this <u>II</u> day of <u>ceptember</u> 2024 between <u>DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE 1</u> (DSWD FO 1 for brevity) of Quezon Avenue, City of San Fernando, La Union, Philippines, represented by its Regional Director, MARIE ANGELA S. GOPALAN and duly authorized for the purpose, hereinafter called the "DSWD FO 1" of the one part and <u>M.G. SERRANO</u> <u>ENTERPRISE</u> of 1337 Pau St., Calulut, San Fernando City, Pampanga, represented by its Owner, MR. MARVIN G. SERRANO, hereinafter called the "SUPPLIER" of the other part;

WHEREAS the **DSWD FO 1** invited Bids for certain goods and ancillary services, particularly for **SUPPLY AND DELIVERY OF GROCERIES FOR THE CHILDREN BENEFICIARIES OF 14**TH **CYCLE (CY 2024-2025) SUPPLEMENTARY FEEDING PROGRAM IN REGION 1 – LOT NO. 4 PANGASINAN** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **Eighteen Million Two Hundred Eight Thousand Seven Hundred Ninety Pesos (PhP18,208,790.00) Only**, hereinafter called the "**CONTRACT PRICE**".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents are required by the 2016 revised Implementing Rules and Regulations of Section 37.2.3 of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);

 - iii. General and Special Conditions of Contract are hereto attached; and
 - iv. Supplemental or Bid Bulletins is hereto attached, if any;
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation are hereto attached;

- iii. Performance Security is hereto attached;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto attached;
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Eighteen Million Two Hundred Eight Thousand Seven Hundred Ninety Pesos (PhP18,208,790.00) Only, as contract price or such other sums as may be ascertained, M.G. Serrano Enterprise agrees to provide Supply and Delivery of groceries for the children beneficiaries of 14th cycle (cy 2024-2025) Supplementary Feeding Program in region 1 – lot No. 4 Pangasinan in accordance with his/her/its Bid.

The **DSWD FO 1** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
