# CONTRACT AGREEMENT

In consideration for the sum of One Million Four Hundred Thirty-four Thousand Ninety Pesos (Php1,434,090.00) Only, as contract price or such other sums as may be ascertained, Joneco Tech Marketing Corp. agrees to provide Procurement of Information Technology Equipment for Sustainable Livelihood Program staff in accordance with his/her/its Bid.
